A Walk-in-interview will be held as per the following schedule for temporary engagement of Retired Associate Professor/ Professor/ Adjunct Professors/ Professor Emeritus/ Professor of Practice/ Assistant Professors/ Guest Faculties against additionally allowed teaching positions of Assistant Professors on honorarium basis in various departments of the Vikram Dev University, Jeypore till filling up of the regular posts. Interested candidates having minimum eligibility should attend the interview with their original certificates and mark sheets of all examinations from H.S.C onwards. The candidates must submit filled in Bio-data in the enclosed proforma with all relevant documents in original and self-attested photocopies before the board failing which the applicant will not be allowed to appear the interview. GUIDELINES/ INSTRUCTIONS FOR TEMPORARY ENGAGEMENT OF RETIRED ASSOCIATE PROFESSORS/ PROFESSORS/GUEST FACULTIES/ IN DIFFERENT DEPARTMENTS OF VIKRAM DEV UNIVERSITY, JEYPORE, ODISHA.

1. The vacancies against sanctioned posts in the State Public Universities can be filled up by way of engagement of retired Associate Professors/ Professors/ Adjunct/ Guest Faculties/ Professor emeritus/ Professor of Practice/ Distinguished visiting faculties on periodical basis.

2. This arrangement shall be purely temporary and will continue till the posts are filled up by way of regular recruitment.

3. Category of faculties:

i. The vacancy of Assistant Professor can be filled up by any of the faculty mentioned at point 3 above Retired Associate Professor /Adjunct Professor/ Professor Emeritus /Professor of Practice or by way of engagement of guest faculties. **However, they will be paid at as per norms of Guest faculties only as stated below in the honorarium table. (Sl.No.1 & 2).**

ii. The retired faculties could be from any Govt., aided or Private higher education institution of the Country possessing appropriate qualification.

iii. **Qualification of faculties prescribed by UGC for different categories shall be followed for selection of faculties under these arrangements.**

iv. Guest faculties already engaged by the Universities prior to issue of this guideline may continue at the old rate and in the old pattern against the vacant sanctioned posts. The revised honorarium would be available to the faculties engaged following this guideline.

v. The honorarium of faculties engaged under this arrangement would be met out of non-salary head of the University Budget.

4. **Workload:** While filling up these vacancies, The University VC and Registrar shall ensure that there is sufficient workload for filling up of such vacancies through this arrangement. If required, the VC and Registrar may submit proposal for rationalization of sanctioned posts to the Department.

5. Tenure of engagement:

i. The tenure of engagement of faculties under this arrangement shall be for a maximum period of **six months or till completion of the regular recruitment process, whichever is earlier.**

ii. The continuation of engagement shall be subject to satisfactory performance during the quarterly review.

iii. The engaged Retired Faculties may continue with the Teaching till they attain 70 years of age, subject to periodical review of satisfactory performance.

*Note The number of Faculty Position may increase or decrease as per the requirement.

7.Qualification:

Qualification of faculties prescribed by UGC guidelines for different categories shall be allowed for selection of faculties under this arrangement.

- Candidates without Ph.D qualification are eligible for Sl No. 2 at the Honorarium Table/ Section.

8.Eligibility for Professor of Practice:

i. Distinguished experts who have made remarkable contribution in their professions from various fields such as engineering, science, technology, entrepreneurship, commerce, social science, media, literature, fine arts, civil services, armed forces, legal profession, community development, panchayati raj, rural development, watershed development, water-harvesting, organic farming, small green energy system, municipal planning, community participation, gender budgeting/ planning, inclusive development of tribal and public administration among others. Those who have proven expertise in their specific profession or role with at least 15 years of service/ experience, preferably at a senior level, will be eligible for Professor of Practice.

ii. A formal academic qualification is not considered essential for this position if they have exemplary professional practice in lieu. These experts will also be exempted from the requirement of publications and other eligibility criteria stipulated for the recruitment of faculty members at the Professor level. However, they should possess the skills to carry out the duties and responsibilities specified in the following section.

9.Eligibility for Adjunct Professor:

Candidate for adjunct faculty should satisfy the following norms:-

For Conventional Higher Education Courses:

- Should have the minimum qualifications as prescribed in the regulations framed by UGC/ respective statutory councils from time to time OR
- A person of eminence with or without a postgraduate or Ph.D. qualifications.

10. Honorarium:

i. Honorarium shall be paid to faculties as per details given below.

1	Guest faculty/ Retired Assistant Professors/ Associate Professors/ Professors/ Adjunct Professors/ Professor emeritus/ Professor of Practice with PhD Degree and to be engaged for PG Courses against the vacant post of Assistant professor	Teaching. If more than 40 classes in any month is taken, then one has to undertake administrative assignment as given by university from the subsequent month onwards. *If less than prescribed classes are undertaken by retired faculties, the honorarium can be given proportionately or shortfall can be adjusted against workload of immediate next month.

**No other allowances or financial benefits are allowed in favour of retired teachers/ guest faculties.

Note: The Professors/ Associate Professors / Adjunct Professors/ Guest faculty Members / Professor Emeritus / Professor of Practice / Distinguished Visiting Faculties will be selected as per existing UGC guidelines. Their Honorarium will be limited as per the maximum monthly honorarium limit as in the above table.

ii. The retired Professors/ Associate Professors / Adjunct Professors/ Guest faculty Members / Professor Emeritus / Professor of Practice / Distinguished Visiting Faculties, etc. engaged against post of Assistant Professor will be allowed to avail 10 days leave in a year.

iii. The payment of all statutory taxes including the income tax will be the sole responsibility of the Professors/ Associate Professors / Adjunct Professors/ Guest faculty Members / Professor Emeritus / Professor of Practice / Distinguished Visiting Faculties etc themselves.

iv. All statutory deductions including tax deduction at source (TDS) will be deducted by the University against the payable remuneration at applicable rates as per the prevailing laws, rules and regulations.

11. Selection criteria for the Post of Professors/ Associate Professors / Adjunct Professors/ Guest faculty Members / Professor Emeritus / Professor of Practice / Distinguished Visiting Faculties.

12. Duties and Responsibilities of the Faculties engaged:

- The faculties engaged under this arrangement shall have the following additional duties and responsibilities, over and above as mentioned against work assignment at point 4 above.
- Academic work like teaching courses, conducting examination and research guidance. They will be entitled to guide research projects of UG and PG students. However, in case of research projects or Guiding Ph.D they will be eligible to become Co guides depending on their qualifications and experience.
- Conducting research and/or taking up sponsored research projects as per the rules and regulations of the funding agency.
- Launching continuing education program in new and emerging areas.
- Organizing/attending National/International Conferences/Seminars / Symposia / Workshops with a co-organizer from the University / college but without any financial commitment from the University.
- Undertaking knowledge-based advisory / consultancy assignments in accordance with the University guidelines.
- Accepting invitations and delivering guest lectures at other institutions.
- Participation in academic/research Committees at the University and elsewhere, when required.
- However, they shall not be eligible for holding administrative or financial responsibilities.

13. General Instructions:

- a. Applicants are required to submit the Bio data as enclosed in the prescribed forms and other certificates and testimonials.
- b. The applicant will be solely responsible for the authenticity of the submitted information.
- c. The details regarding qualifications, experience and screening guidelines are available on the University website <https://vikramdevuniversity.ac.in/> along with this the advertisement. The applicants are required to read these details before filling up form.
- d. Applicants should possess the prescribed qualifications and experience as on the date of submission of application as prescribed by the University for the respective posts. The posts carry the honorarium as prescribed by the Govt. of Odisha in Higher Education Department.
- e. Publication 'under submission' or submitted to referees shall not be considered towards calculation of marks for publication criteria. Further, all the items for which marks are claimed should be strictly in accordance with the screening guidelines attached with the advertisement.
- f. The time taken by candidates to acquire M. Phil. and/or Ph.D Degree shall not be considered as teaching/research experience to be claimed for appointment to the teaching positions. Further, the period of active service spent on pursuing research degree simultaneously with teaching assignment without taking any kind of leave, shall be counted as teaching experience.
- g. No TA/DA shall be paid to applicants for attending interview.
- h. The university reserves the right to amend the number of posts or not to fill any of the posts mentioned in the advertisement without assigning any reason thereof. Any consequential vacancies arising at the time of interview may also be filled up from the available screened candidates.
- i. The applicants must NOT furnish any particulars that are false, tampered or fabricated, or suppress any material information while submitting the application and self-certified copies/testimonials.
