Notice for engagement of "Persons on daily wages basis (purely on temporary basis) to work in the Courts / Offices of the Judgeship of Jharsuguda to meet the required services of Group-'D' employees till completion of the entire recruitment process and appointment of Group-'D' staff in the District & Subordinate Courts of the State under the Odisha District & Subordinate Courts' Group-'D' Employees (Method of Recruitment and Conditions of Service) Rules, 2021.

The engagement is purely on temporary basis purely on temporary and is terminable at time. The persons so engaged shall be paid daily wages of Rs.462/- (Rupees Four Hundred Sixty Two only) per day (Unskilled Category) as per the Government of Odisha Notification No. 2602/LC Bhubaneswar, dtd.30.04.2025 issued vide Memo No. 2604 dated 30.04.2025 from office of the Labour Commissioner, Odisha, Bhubaneswar which shall be enhanced from time to time as would be fixed by the Govt. of Odisha. The age of applicant shall not below 18 years and above 32 years as on 19.06.2026. The engagement will confer no right to claim for appointment on regular basis. The applicants should have the following criteria:-

- i. Must be a citizen of India
- ii. Must have passed at least M.E. standard (Class-VII) examination from a recognised institution.
- iii. Shall not be below 18 years and above 32 years of age till the date of apply.
- iv. Must be able to speak, read and write in Odia
- v. Have elementary knowledge in English

- vi. Shall be of good character
- vii. Be of sound health and free from organic defect or bodily infirmity.

- ix. Application incomplete in any respect or received beyond the stipulated date and time shall be rejected.
