

**PROCEEDING OF THE SCRUTINY COMMITTEE MEETING HELD ON
08.07.2026 AT 05.00 PM IN THE COLLECTORATE, KALAHANDI FOR
SCRUTINY OF APPLICATIONS RECEIVED FOR SETTLEMENT OF
IMFL 'OFF' SHOPS FOR THE YEAR 2026-27 ONWARDS THROUGH
LOTTERY PROCESS**

In pursuance of the provisions contained in **SRO No.266/2026 Dated.26.03.2026** and subsequent **Corrigendum/amendment of Government in Excise Department, Odisha, Bhubaneswar** and in accordance with the terms and conditions stipulated in the **Sale Notice for settlement of IMFL 'OFF' Shops for the year 2026-27 published vide Notice No.1329/Ex Dated.23.06.2026 of Collector, Kalahandi**, the Scrutiny Committee meeting was held on **08.07.2026 at 05.00 PM** in the **Collectorate, Kalahandi** under the Chairmanship of the **Additional District Magistrate (General), Kalahandi** for scrutiny of applications received through the **e-Abakari Portal** for settlement of IMFL 'OFF' Shops in Kalahandi district through lottery process.

The following members were present in the meeting:

5. **Addl. District Magistrate (Gen), Kalahandi** – Chairman & Nodal Officer
6. **Deputy Collector (Establishment), Collectorate. Kalahandi** – Member
7. **Superintendent of Excise, Kalahandi** – Member-cum-Convener
8. **District Informatics Officer (NIC), Kalahandi** – Member & Technical Support

At the outset, the Chairman welcomed all the members of the Committee and explained the purpose of convening the meeting. He emphasized that the scrutiny process should be conducted strictly in accordance with the provisions of the Government guidelines and the eligibility criteria prescribed in the Sale Notice to ensure transparency and fairness in the lottery process.

The **Superintendent of Excise, Kalahandi**, being the Member-cum-Convener, placed before the Committee the details of applications received through the **e-Abakari Portal** for settlement of IMFL 'OFF' Shops and explained in detail the eligibility conditions, required documents and scrutiny procedure prescribed under the Sale Notice. The Committee thereafter took up the applications for detailed scrutiny shop-wise and application-wise.

During scrutiny, it was observed that against a total of **02 notified IMFL 'OFF' Shops** in Kalahandi district, a total of **10 applications** had been received through the **e-Abakari Portal**.

The Committee scrutinized all the applications received for the aforesaid 02 IMFL 'OFF' Shops with reference to the eligibility criteria and supporting documents submitted by the applicants, including verification of particulars furnished in the online applications and documents uploaded in the portal.

After detailed scrutiny and examination of the applications and supporting documents, the Committee found that **all the 10 applicants had submitted the required documents in accordance with the terms and conditions prescribed in the Sale Notice and were found eligible for participation in the lottery process.**


Accordingly, the Committee unanimously resolved that **all the 10 eligible applications received against 02 IMFL 'OFF' Shops** may be recommended for inclusion in the lottery process for settlement of IMFL 'OFF' Shops for the year **2026-27 onwards.**


The shop-wise details of applications received are as follows:

- **Total eligible applications after scrutiny: 10**


